HOT HUES AWARD TERMS & CONDITIONS

This contest is open to classic automobiles, street rods, custom cars, trucks, import compact, race cars and other motorized passenger vehicles such as motorcycles, aircraft and watercraft finished **with Hot Hues Custom Finishes**. Contestants must be legal residents of the continental United States, Canada or Mexico, 18 years of age or older, and own or have refinished the vehicle to be entered. **Prizes will be awarded to the entrants, whether they are owners or refinishers and are non-transferable.**

Entry forms must be completed in full and be accompanied by a color 3"x5" photograph of the vehicle to be judged. All entries will be judged by a panel of Refinish experts. 12 Grand Prize winners will be selected. Criteria for "best use of color" is based on finish quality, including technical difficulty, design originality, and artistic merit. The decision of the judges is final.

Each Grand Prize winner will receive an engraved Hot Hues Crystal award, 14"x10" high quality print of their vehicle for framing and Hot Hues Merchandise Prize Package consisting of one each of the following: Hot Hues leather jacket, hat, t-shirt, key chain, "do not touch" static decal, metal grip pen, sports bottle, and paint mixing apron. In addition, each vehicle will be featured (full-page) in the 2008 Hot Hues Calendar. Each Grand Prize winner will receive 25 copies of the calendar. Grand Prize winning vehicles and winners' names will also appear in *DuPont Refinisher News*.

Entries must be postmarked by APRIL 30, 2007. All entries become the property of DuPont Performance Coatings and will not be returned.
